### Reportable Incidents

Help guard against the collection efforts of Foreign Intelligence Services (FIS) and the Terrorist related Insider Threat. Here are some behaviors to watch for:

### Terrorist Insider Threat Indicators

Advocating Violence, the Threat of Violence, or Use of Force to Achieve Goals that are Political, Religious, or Ideological in Nature

Advocating Support for International Terrorist Organizations or Objectives

Providing Financial or Other Material Support to a Terrorist Organization or to Someone Suspected of Being a Terrorist

Association with or Connections to Known or Suspected Terrorist

Repeated Expression of Hatred and Intolerance of American Society, Culture, Government, or Principles of the U.S. Constitution

Repeated Visiting or Browsing of Internet Websites that Promote or Advocate Violence Against the U.S. or U.S. Forces, or that Promotes International Terrorism or Terrorist Themes

Expressing an Obligation to Engage in Violence in Support of International Terrorism or Inciting Others to do the Same

Purchasing Bomb Making Materials or Obtaining Information about the Construction of Explosives

Family Ties to Known or Suspected Terrorists or Terrorist Supporters

### Potential Indicators of Espionage:

Sudden Undue Affluence or Reversal of Financial Situation

Unexplained Trips to Foreign Countries

Unexplained Foreign Contact

Taking Classified Work Home

Repeated Security Violations

Excessive Photocopying of Classified Information

Unauthorized Attempts to Expand Access

Works Unusual Hours to be Alone in the Office

Joking or Bragging about Working for Foreign Government

## 902D Military Intelligence Group TARP Information Card

### IF YOU ENCOUNTER A SUSPICIOUS INCIDENT, REMEMBER:

Do not commit yourself to anything. Ask for time to think over any offers.

Remember all descriptions and details about people, conversations, locations, vehicles, and license plates.

Do not investigate the incident yourself.

Do not discuss the incident with anyone except Special Agents of the U.S. Army Intelligence.

Report the incident immediately to the closest Military Intelligence office.

**Remember, AR 381-12 requires you to report suspected TARP incidents. Don't take a chance! Call MI.**
